"A RESOLUTION RECOMMENDING THE AWARD OF P.R. NO. 22-2082 TO POSITIVE BUILDERS AND TRADING"

WHEREAS, the Provincial Government of Pampanga published in accordance with law an invitation to bid for P.R. No 22-2082- "To supply labor, materials and necessary equipment for the Rehabilitation/Improvement of Sindalan-Anao Road (San Pedro Camuning Section) at San Pedro Camuning, Mexico, Pampanga" with an approved budget for the contract in the amount of Twelve Million Five Hundred Twenty Eight Thousand Eight Hundred Twenty Three Pesos and 14/100 Philippine Currency (Php 12,528,823.14).

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on July 13, 2022, wherein two (2) bidders, **POSITIVE BUILDERS AND TRADING** and **ALFREDO D. SANTOS CONSTRUCTION**, submitted their bids which when opened revealed to be compliant with the eligibility and technical requirements as stated in the Bidding Documents using a discretionary "pass/fail" criteria;

WHEREAS, evaluation of the financial proposals of the said bidders resulted in the following:

WHEREAS, based on the above evaluation, the Bids and Awards Committee declared the bid of **POSITIVE BUILDERS AND TRADING** as the Lowest Calculated Bid;

WHEREAS, upon careful examination, validation and verification of all the ~~eligibility~~ technical and financial requirements submitted by **POSITIVE BUILDERS AND TRADING**, by way of post qualification, the Bids and Awards Committee found that its bid has passed all the criteria and was thus declared as the Lowest Calculated and Responsive Bid for PR No. 22-2082 in the amount of **Twelve Million Four Hundred Seventy Thousand Twelve Pesos and 77/100, Philippine Currency (Php 12,470,012.77)**;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:



RESOLVED FURTHER, to submit the foregoing recommendations to the Head of the Procuring Entity for approval.


