**"A RESOLUTION AWARDING PURCHASE REQUEST NO. 21-2294  
TO BRIXMED PHARMA CARE, INC."**

**WHEREAS**, the Provincial Government of Pampanga published in accordance with law an invitation to bid for **P.R. # 21-2294 – Supply and Delivery of 11,008 vials Anti-Rabies Vaccine/Serum (Re-bidding)** with an approved budget for the contract in the amount of Nineteen Million Two Hundred Seventy Thousand Fifty Pesos, Philippine Currency (PhP 19,270,050.00);

**WHEREAS**, pursuant to the aforesaid invitation, a public bidding was held on April 06, 2022, wherein three (3) bidders submitted their bids, namely, **Ayscee Enterprises, JPMR Pharma** and **Brixmed Pharma Care, Inc.**, which when opened revealed to be compliant with the eligibility and technical requirements as stated in the Bidding Documents using a discretionary "pass/fail" criteria;

**WHEREAS**, during the bid evaluation process, the bid of the first ranked bidder, **Ayscee Enterprises** was declared non-complying on the following grounds: "The submitted price schedule is NOT in compliance with the Mandatory Provisions of Required Forms under GPPB Resolution No. 16-2020 and Bidding Documents Section 12 of the Instruction to Bidders";

**WHEREAS**, the Committee instructed the Secretariat to inform the bidder of its non-compliance during detailed bid evaluation, and without prejudice to whatever remedy the bidder may take, declared the second ranked bidder, **JPMR Pharma** as the Lowest Calculated Bid and further instructed the Technical Working Group to conduct the post-qualification evaluation to the said bidder

**WHEREAS, Ayscee Enterprises,** timely filed a motion for reconsideration on April 18, 2022;

**WHEREAS,** upon evaluation of the motion, the Technical Working Group (TWG) recommended that the Motion for Reconsideration of **Ayscee Enterprises** be granted and to proceed with the Post-Qualification process;

**WHEREAS,** the BAC -TWG, in its letter dated May 13, 2022 recommended the Post-disqualification of **Ayscee Enterprises**

**WHEREAS, Ayscee Enterprises,** did not file a motion for reconsideration within the required period;

**WHEREAS,** during the post-qualification process of the second ranked bidder, the bid of **JPMR Pharma** was found to be non-complying on the following grounds: Failed to submit the required documents within five (5) calendar days as specified in the ITB Clause 20.2 of the Instruction to Bidders;

**WHEREAS,** the Committee instructed the Secretariat to inform the bidder of its post-disqualification, and without prejudice to whatever remedy the bidder may take, declared the third ranked bidder, **Brixmed Pharma Care, Inc.** as the Lowest Calculated Bid and further instructed the TWG to conduct the post-qualification evaluation of the said bidder;

**WHEREAS, JPMR Pharma,** did not file a motion for reconsideration within the required period;

**WHEREAS,** after careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Brixmed Phatрма Care, Inc.** by way of post-qualification, the BAC found that its bid has passed all the criteria and was thus declared as the Lowest Calculated Responsive Bid in the amount of **Nineteen Million Two Hundred Thirty Thousand Five Hundred Forty Two Pesos, Philippine Currency ( PhP 19,230,542.00);**

**NOW THEREFORE,** the members of the Bids and Awards Committee, in regular session assembled;

**RESOLVED,** as it is hereby resolved, to recommend the award of the contract to **Brixmed Pharma Care, Inc.** in the amount of **PhP 19,230,542.00** in accordance with R.A. No. 9184 and its Revised IRR;


