WHEREAS, on July 21, 2022 the IG-BAC pursuant to Sec 53.9 of the IRR of RA 9184 posted a Request for Quotation No. 220371 for PR No. 22-1530- **“To supply labor, materials and necessary equipment for the Construction/Improvement of Storage at Lower Portion of Ground Floor Stair and Toilet Cabinet at 3rd Floor of Legislative Building at Sto. Nino, Capitol Compound, City of San Fernando, Pampanga (Re-posting)** with an approved budget for the contract in the amount of Seventy Four Thousand One Hundred Forty One Pesos and 03/100 Philippine Currency (Php 74,141.03);

WHEREAS, aside from posting of the said RFQ, three suppliers were invited to submit their quotation for the said project namely: J.E.P.M. 09 Construction and Trading, Golden Jac Builders and Kezia Builders and Supply;

WHEREAS, only one supplier, **J.E.P.M. 09 Construction and Trading**, submitted its quotation in the amount of **Seventy Three Thousand Eight Hundred Forty Nine Pesos and 15/100 (Php 73,849.15)** which was referred to the TWG for evaluation;

WHEREAS, after evaluation of financial proposal, the Bids and Awards Committee adopted the recommendation of the TWG and declared the bid of **J.E.P.M. 09 Construction and Trading** as the Single Calculated Quotation;

WHEREAS, in its letter dated August 15, 2022, the TWG recommended for the awarding of the contract to **J.E.P.M. 09 Construction and Trading** finding it to be complying with the checklist of documents and the detailed evaluation of the financial component to establish the correct calculated price in the amount of **Seventy Three Thousand Eight Hundred Forty Nine Pesos and 15/100 (Php 73,849.15)**;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:

RESOLVED, as it is hereby resolved, to recommend the award of the said contract to **J.E.P.M. 09 Construction and Trading** in the amount of **Seventy Three Thousand Eight Hundred Forty Nine Pesos and 15/100 (Php 73,849.15)** in accordance with R.A. 9184 and its Revised IRR;
