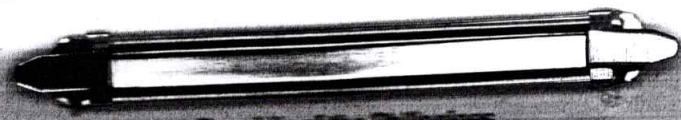

THIS AGREEMENT, made this _____ day of _____ 2022 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **BABY E CONSTRUCTION** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute – (To supply labor, materials and necessary equipment for the Concreting of Barangay Road at Culubasa, Mexico, Pampanga) (hereinafter called "the Works") and the Entity has accepted the Bid for (Two Million Four Hundred Eighty Three Thousand Three Hundred Eighty Nine Pesos and 41/100, Philippine Currency (PhP 2,483,389.41)) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.





THIS AGREEMENT, made this 19 OCT 2022 day of 2022, between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **ISENCHEL CONSUMER GOODS TRADING** hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply and Delivery of 2,000 packs – Full Cream Milk Powder, 1.8kg.] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(One Million Seven Hundred Thousand Pesos, Philippine Currency (PhP 1,700,000.00)) (hereinafter called "the Contract Price")].
