BIDS AND AWARDS COMMITTEE BAC RESOLUTION NO. 2022- 120 DGP

"A RESOLUTION RECOMMENDING THE AWARD OF P.R. NO. 22-1050 TO ALFREDO D. SANTOS CONSTRUCTION"

WHEREAS, on March 28, 2022 the IG-BAC pursuant to Sec. 53.9 of the IRR of RA 9184 posted a Request for Quotation No. 220205 for P.R. No. 22-1050- "To supply labor, materials and necessary tools and equipment for the Improvement of New MIS Office, (Formerly BIR Building), Capitol, Compound, Sto. Niño, City of San Fernando, Pampanga" with an approved budget for the contract in the amount of Four Hundred Eighty Four Thousand Three Hundred Thirty Three Pesos and 27/100 Philippine Currency (Php 484,333.27).

WHEREAS, aside from posting of the said RFQ, three suppliers were invited to submit their quotation for the said project namely: <u>Alfredo D. Santos Construction</u>, MAM Construction and J.D. Venzon Construction;

WHEREAS, only one supplier, Alfredo D. Santos Construction, submitted its quotation in the amount of Four Hundred Eighty Three Thousand Nine Hundred Twenty Five Pesos and 69/100, Philippine Currency (Php 483,925.69) which was referred to the TWG for evaluation;

WHEREAS, after evaluation of the financial proposal, the BAC declared the offer of **Alfredo D. Santos Construction** as the Single Calculated Quotation;

WHEREAS, in its letter dated April 6, 2022, the TWG recommended for the awarding of the contract to Alfredo D. Santos Construction, finding it to be complying with the checklist of documents and the detailed evaluation of the financial component to establish the correct calculated price in the amount of Four Hundred Eighty Three Thousand Nine Hundred Twenty Five Pesos and 69/100, Philippine Currency (Php 483,925.69);

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:

RESOLVED, FURTHER, to recommend the award of the said contract to Alfredo D. Santos Construction in the amount of Four Hundred Eighty Three Thousand Nine Hundred Twenty Five Pesos and 69/100, Philippine Currency (Php 483,925.69) in accordance with RA 9184 and its Revised IRR;

RESOLVED FINALLY, to submit the foregoing recommendations to the Head of the Procuring Entity for approval with the further recommendation that the Implementation of the project is subject to Comelec Resolution No. 10747;
