



Contract Agreement

THIS AGREEMENT, made this _____ day of _____, 2022 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **ARIK GENERAL MERCHANDISING** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply, Delivery and Installation of 2 units Flexible Plastic Skate Wheel Conveyor & 1 set Automatic Weighing & Packing Machine] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(Three Million Eight Hundred Eighty Five Thousand Pesos, Philippine Currency (PhP 3,885,000.00)] (hereinafter called "the Contract Price").

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.

In consideration for the sum of **Three Million Eight Hundred Eighty Five Thousand Pesos (PhP 3,885,000.00)** or such other sums as may be ascertained, **Arik General Merchandising** agrees to the **Supply, Delivery and Installation of 2 units Flexible Plastic Skate Wheel Conveyor & 1 set Automatic Weighing & Packing Machine** in accordance with its Bid.




