



Contract Agreement

THIS AGREEMENT, made this _____ day of _____, 2022 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **YASLIL LANTERN & GENERAL MERCHANDISE** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [**Supply, Delivery, Installation and Repair of Christmas Lanterns**] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(**Three Million Three Hundred Sixty Six Thousand Two Hundred Fifteen Pesos, Philippine Currency (PhP 3,366,215.00)**] (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental /Bid Bulletins, if any;
 - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.

In consideration for the sum of **Three Million Three Hundred Sixty Six Thousand Two Hundred Fifteen Pesos (PhP 3,366,215.00)** or such other sums as may be ascertained, **Yaslil Lantern and General Merchandise** agrees to the **Supply, Delivery, Installation and Repair of Christmas Lanterns** in accordance with its Bid.

4. The **PROVINCIAL GOVERNMENT OF PAMPANGA** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
