**"A RESOLUTION RECOMMENDING THE
PROCUREMENT OF P.R. NO. 22-4799 THROUGH
NEGOTIATED PROCUREMENT (EMERGENCY
CASES)"**

WHEREAS, the Provincial Engineer's Office, requested the procurement of the following item through its purchase request P. R. NO. 22-4799 dated December 21, 2022;

22-4799	To supply Labor, Materials and Necessary Equipment for the Improvement of Sta. Ana – Magalang Road (San Roque Station) with Slope Protection at San Roque, Sta. Ana, Pampanga, as per approved Program of Work, Plans and Specifications	Php1,665,877.54

WHEREAS, Engr. Bryan Alvarado of the Office of the Provincial Engineer appeared in today's session to request the procurement of the item through an alternative mode of procurement under

Emergency Cases on the ground that there is a need for the immediate repair of the damaged portion of the road considering that it is a major thoroughfare that is within the jurisdiction of the PEO and that it also very dangerous especially at night;

WHEREAS, Section 53.2 of the Updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, negotiated procurement through Emergency Cases may be resorted “[i]n case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes **where immediate action is necessary** to prevent damage to or loss of life or property, or to **restore vital public services, infrastructure facilities** and other public utilities”;

WHEREAS, paragraph (V)(D)(2)(b)(iii) of Annex “H” of the same Updated 2016 Revised IRR, provides that “[t]he HoPE may delegate to either the BAC or the End-user unit or any other appropriate bureau, committee, support or procuring unit the authority to directly negotiate with a legally, technically, and financially capable supplier, contractor, or consultant for procurement undertaken through any of the allowable instances of Negotiated Procurement (Emergency Cases) under Section 53.2 of the 2016 revised IRR”. Further in paragraph (iv), “[u]pon confirmation and ascertainment of such capability to address the emergency, the HoPE, upon recommendation of the BAC or the End-user unit or any other appropriate bureau, committee, support or procuring unit, authorized for the purpose shall immediately award the contract to the Supplier, Contractor or Consultant.

WHEREAS, the Committee finds the justification of the end-user meritorious and considers the item requested as appropriate for emergency procurement as immediate action is necessary to restore infrastructure facilities to prevent damage to or loss of life or property;

WHEREAS, the Committee further feels that it is best for the End User to directly negotiate with a legally, technically, and financially capable supplier for immediate and urgent results;

NOW THEREFORE, the members of the IG-Bids and Awards Committee, in regular session assembled:

RESOLVED, as it is hereby resolved, to recommend:

- (1) To resort to the modality of Negotiated Procurement (Emergency Cases) under Section 53.2 of the Updated 2016

Revised IRR and Annex "H" of the same IRR in the procurement of P.R. No. 22-4799;

(2) To allow the End User unit to recommend to the HoPE any revision of the Annual Procurement Plan (APP) to cover the Procurement Project;


(3) To authorize the end-user to directly negotiate with a legally, technically, and financially capable supplier or contractor to execute the works and perform the services to address the emergency, pursuant to paragraph (V)(D)(2)(b)(iii) of Annex "H" of the same Updated 2016 IRR;

(4) For the Designated HOPE to immediately award the contract to the selected supplier or contractor upon recommendation of the End-user unit after confirmation and ascertainment of such capability to address the emergency, pursuant to paragraph (V)(D)(2)(b)(iv) of Annex "H" of the same Updated 2016 Revised IRR.

RESOLVED FURTHER, to submit the foregoing recommendation to the Head of the Procuring Entity for approval.
