Terms of Reference

Mangrove Propagation at the Provincial Mangrove Nursery at Brgy. San Antonio, Sasmuan, Pampanga through Community Participation

I. Rationale

Under Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, local government units (LGUs) shall enhance the right of the people to a balanced ecology. Book III, Section 484 of the LGC further provides that the Environment and Natural Resources Officer (ENRO) shall:

- i. Establish, maintain, protect and preserve communal forests, watersheds, tree parks, mangroves, greenbelts and similar forest projects and commercial forest, like industrial tree farms and agroforestry projects;
- ii. Provide extension services to beneficiaries of forest development projects and technical, financial and infrastructure assistance;
- iii. Manage and maintain seed banks and produce seedlings for forest and tree parks; and
- iv. Provide extension services to beneficiaries of forest development projects and render assistance for natural resources-related conservation and utilization activities consistent with ecological balance.

Meanwhile, Sections 35 and 36 of the LGC also recognizes the crucial role of people's and non-governmental organizations (POs and NGOs) as active partners of LGUs in the delivery of basic services and in the implementation of economic, socially-oriented, environmental or cultural projects within their territorial jurisdictions:

Section 35. Linkages with People's and Non-governmental Organizations. - Local government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversity agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people.

Section 36. Assistance to People's and Non-governmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

One of the major thrusts of the Provincial Government as indicated in the Executive-Legislative Agenda (ELA) for 2022-2025 is "Advancing Disaster and Climate Change Resilience and Environment Protection and Preservation for Resilient Kapampangan Communities". Likewise, in light of the Supreme Court (SC) ruling on the Mandanas-Garcia petitions mandating the full devolution of certain functions to local government units (LGU), including environment and natural

resources (ENR) management, the Provincial Government through its Environment and Natural Resources Office (PG-ENRO) has recently established the Pilot Provincial Mangrove Nursery at San Antonio, Sasmuan, Pampanga through community participation.

For this reason, the **DELTAnim Project**, which encourages urban reforestation and forest rehabilitation as a means of contributing to the increase in the province's existing forest cover, was launched on September 2022 at the Mt. Arayat Protected Landscape (MAPL). Some of the propagules produced and housed in the nursery were used for a variety of activities under the DELTAnim project, among which include the conduct of tree-growing activities and provision of mangrove propagules.

To sustain this noble endeavor in contributing to environmental protection and preservation, the PG-ENRO proposes the Mangrove Propagation at the Provincial Mangrove Nursery at Brgy. San Antonio, Sasmuan, Pampanga through Community Participation.

Continuous mangrove propagule production at the Provincial Mangrove Nursery will help replenish the existing supply of mangrove propagules, which will contribute to the Provincial Government's efforts to conserve the environment, alleviate the effects of climate change, promote stakeholder participation, and provide local jobs. Its successful implementation will demand knowledge and expertise in labor as well as mangrove propagation.

To attain social objectives (e.g. poverty reduction, job generation, climate change mitigation) and to ensure sustainability and ownership of the mangrove nursery as embodied by the principles of stakeholder engagement and value for money, the PG-ENRO aims to promote **community participation** by tapping capable and qualified Community or Social Groups (CSGs) for this undertaking, as provided under the Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 or the Government Procurement Reform Act (GPRA), particularly Section 53.12 on Community Participation.

II. Objectives

The main objective of this project is to have a continuous supply of propagules at the Provincial Mangrove Nursery, which shall house various endemic mangrove species to be used in mangrove planting activities to be initiated by the Provincial Government. This project will enjoin the participation of qualified Community or Social Groups (CSGs) capable of producing the mangrove propagule requirement for this project.

Guided by the principles of stakeholder engagement and value for money, the project shall endeavor to achieve the following objectives:

- To provide a source of livelihood for the local community by encouraging the participation of eligible Community or Social Groups (CSGs), which may include but not be limited to civil society organizations (CSOs), community-based organizations (CBOs), people's organizations (POs), and community labor groups;
- To serve as an avenue for poverty alleviation amidst the COVID-19 pandemic and increasing inflation rates by generating local employment, thereby providing a sustainable source of income to the beneficiaries through the labor component of project, which involves mangrove propagation;

- To engage stakeholders and strengthen their ties with the Provincial Government by fostering local ownership of the project, thereby ensuring its sustainability by encouraging the project recipients to consistently manage the project throughout its implementation;
- To produce a sustainable and adequate supply of mangrove propagules of indigenous species to be planted under the DELTAnim Project, which encompasses mangrove planting activities and distribution of mangrove propagules to greenbelts, and other public open spaces; and
- To significantly contribute to the impending Risk Resiliency Program-Climate Change Adaptation and Mitigation (RRP-CCAM) of the DSWD which will be implemented through cash-for-work program by the Provincial Government and its component LGUs from 2023 onwards for 8,509 beneficiaries from all over the province who will be tapped to conduct nursery establishment, planting of various trees, and maintenance and protection of constructed nurseries and established plantations.

III. Project Requirements

The selected Community or Social Group (CSG) shall be required to:

1. Construct a bamboo-made nursery shed measuring 23.00m x 10.60m x 1.80m with black/green mesh net as its covering/roofing.




Figure 2. Proposed Nursery Shed Layout (a)




Figure 2. Proposed Nursery Shed Layout (b)




Figure 2. Proposed Nursery Shed Layout (c)




Figure 2. Proposed Nursery Shed Layout (d)
