





WHEREAS, the Provincial Government of Pampanga published in accordance with law an invitation to bid for **P.R. # 22-1760 – Supply and Delivery of 10,000 packs of Powdered Milk and Oatmeal (Re-bidding)** with an approved budget for the contract in the amount of Five Million Pesos, Philippine Currency (PhP 5,000,000.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on January 25, 2023, wherein Five (5) bidders, **Ramesh Trading Corp., Waffle Time, Inc., HLYC Trading, TSH Corporation** and **Isenchel Consumer Goods Trading**, submitted their bids;

WHEREAS, during the opening of bids, the BAC, using a non-discretionary “pass/fail” criteria determined the following:

- a. The submissions of **Waffle Time, Inc., HLYC Trading, TSH Corporation** and **Isenchel Consumer Goods Trading** as compliant with the eligibility and technical requirements as stated in the Bidding Documents;
- b. The submission of **Ramesh Trading Corp.**, as non-complying for the following grounds: Non-submission of Manpower Requirements and Aftersales Schedule;

WHEREAS, the representative of **Ramesh Trading Corp.** was notified in open session that he may file a Motion for Reconsideration for the Committee's declaration of non-compliance of the company's submitted bid;

WHEREAS, Ramesh Trading Corp. did not file a motion for reconsideration within the required period;

WHEREAS, during the detailed evaluation process, the bid of **TSH Corporation** (Rank 1) was found to be non-complying due to the insufficient Single Largest Completed Contract submitted and **Waffle Time, Inc.** (Rank 2) was also found to be non-complying due to the non-inclusion of all the mandatory provisions on the submitted omnibus sworn statement;

WHEREAS, based on the above, the Committee declared the bid of **TSH Corporation** and **Waffle Time, Inc.** as non-compliant and instructed the Secretariat to notify the bidders of their non-compliance and the reasons therefor;

WHEREAS, the Committee declared the bid of **Isenchel Consumer Goods Trading** (Rank 3) as the Lowest Calculated Bid and instructed the TWG to proceed with the post-qualification process without prejudice to the filing of a motion for reconsideration by **TSH Corporation** and **Waffle Time, Inc.**;

WHEREAS, Waffle Time, Inc. did not file a motion for reconsideration while **TSH Corporation** timely filed a motion for reconsideration but was subsequently denied in session on February 15, 2023 upon recommendation of the BAC-TWG;

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Isenchel Consumer Goods Trading** by way of post-qualification, the BAC found that its bid has passed all the criteria and was thus declared as the **Lowest Calculated Responsive Bid** in the amount of **Four Million Two Hundred Thousand Pesos, Philippine Currency (PhP 4,200,000.00)**;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:




NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:


