

THIS AGREEMENT, made this _____ day of _____, 2023 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **BABY E. Construction** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute [To supply labor, materials and necessary tools and equipment for the Construction of Multi-Purpose Building at San Fernando Elementary School, City of San Fernando, Pampanga] (hereinafter called "the Works") and the Entity has accepted the Bid for [Four Million Two Hundred Sixty Six Thousand Sixty Three Pesos and 42/100, Philippine Currency (Php 4,266,063.42)] by the Contractor for the execution and completion of such Works and the remedying of any defects therein

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
