




THIS AGREEMENT, made this _____ day of _____, 2023 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **SG BIOPHARMA PHARMACEUTICAL PRODUCTS TRADING** (hereinafter called the "Supplier").
