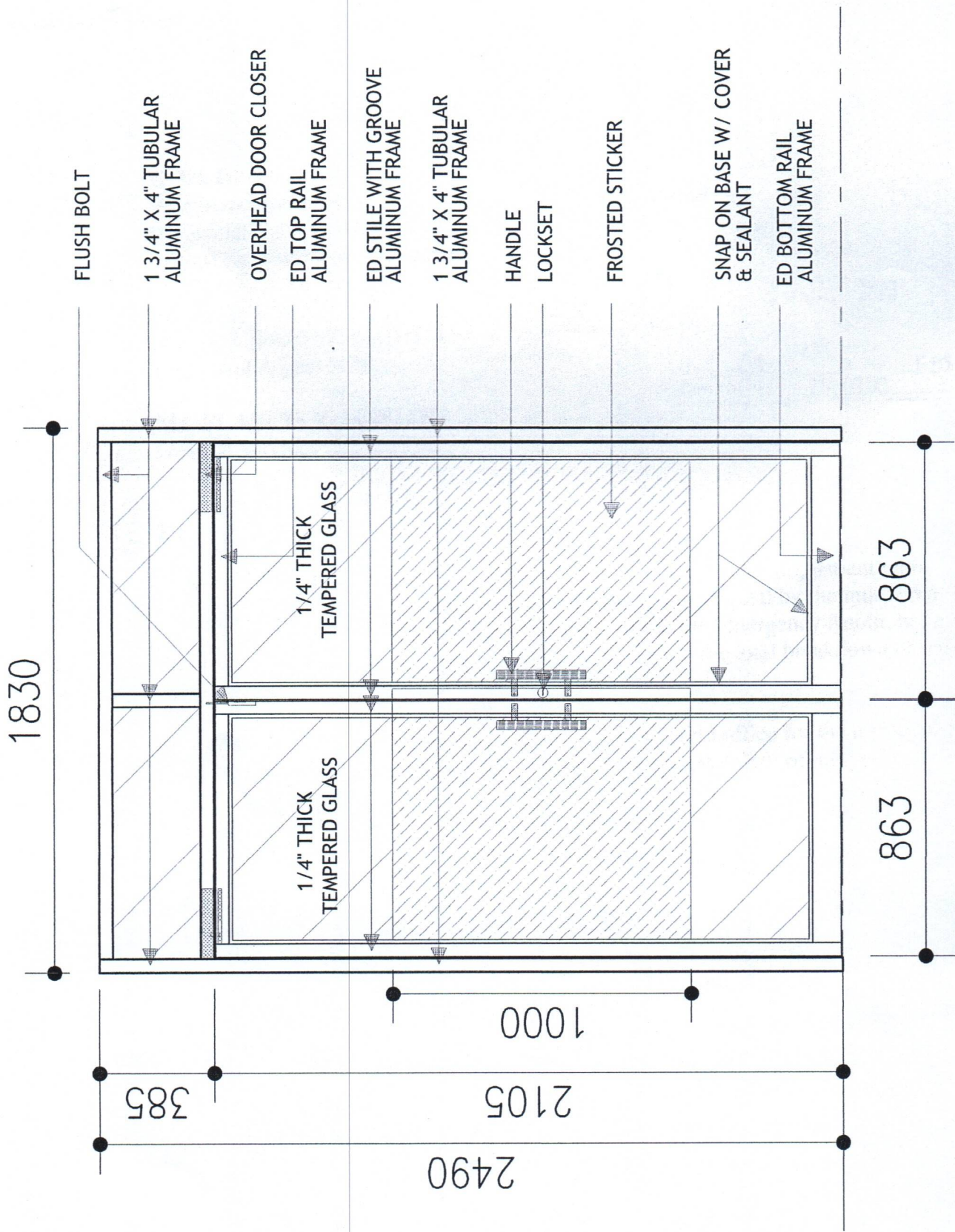
TERMS AND CONDITIONS:
