"A RESOLUTION AWARDING PURCHASE REQUEST NO. 22-3759 TO BRIXMED PHARMA CARE, INC."

WHEREAS, the Provincial Government of Pampanga published in accordance with law an invitation to bid for P.R. # 22-3759 – Supply and Delivery of 3,242 vials - Anti-Rabies Vaccine with an approved budget for the contract in the amount of Six Million Nine Hundred Ninety Seven Thousand Four Hundred Pesos, Philippine Currency (PhP 6,997,400.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on January 18, 2023, wherein two (2) bidders submitted their bids, namely, Mauricio Pharma Trading and Brixmed Pharma Care, Inc., which when opened revealed to be compliant with the eligibility and technical requirements as stated in the Bidding Documents using a discretionary "pass/fail" criteria;

WHEREAS, during the post-qualification process, the bid of the first ranked bidder, **Mauricio Pharma Trading** was declared non-complying on the following grounds: "The submitted Omnibus Sworn Statement is not in compliance with GPPB Resolution No. 16-2020 & 04-2020 Section 6.0 Mandatory Provisions of Required Forms";

WHEREAS, the Committee instructed the Secretariat to inform the bidder of its post-disqualification, and without prejudice to whatever remedy the bidder may take, declared the second ranked bidder, **Brixmed Pharma Care**, Inc. as the Lowest Calculated Bid and further instructed the Technical Working Group to conduct the post-qualification

Mauricio Pharma Trading, did not file a motion for reconsideration WHEREAS. within the required period, despite notice;

WHEREAS, after careful examination, validation and verification of all eligibility, technical and financial requirements submitted by Brixmed Pharma Care, Inc. by way of post-qualification, the BAC found that its bid has passed all the criteria and was, thus declared as the Lowest Calculated Responsive Bid in the amount of Six Million Nine Hundred Ninety Thousand Six Hundred Ninety Pesos, Philippine Currency (PhP 6,990,690.00);

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:

RESOLVED, as it is hereby resolved, to recommend the award of the contract to Brixmed Pharma Care, Inc., in the amount of PhP 6,990,690.00 in accordance with R.A. No. 9184 and its Revised IRR;

RESOLVED FURTHER, to submit the foregoing recommendation to the Head of the Procuring Entity (HOPE) for approval.



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of (Four Million Two Hundred Sixty Eight Thousand Six Hundred Eleven Pesos and 35/100, Philippine Currency (PhP 4,268,611,35) or such other sums as may be ascertained, BABY E CONSTRUCTION agrees To supply labor, materials and necessary equipment for the Construction of Multi-Purpose Covered Area at San Jose Floridablanca, Pampanga in accordance with its Bid.
