**“A RESOLUTION RECOMMENDING THE AWARD OF P.R. NO.  
22-4106 TO CREDIBUILD DEVELOPMENT CORPORATION”**

**WHEREAS**, the Provincial Government of Pampanga published in accordance with law an invitation to bid for **P.R. No. 22-4106– Design and Build of Central Healthcare Wastewater Treatment Facilities for Provincial and Various District Hospitals** with an approved budget for the contract in the amount of One Hundred Ninety Three Million Two Hundred Fourteen Thousand Three Hundred Eighty Five Pesos and 00/100 Philippine Currency (PhP 193,214,385.00);

**WHEREAS**, in response to the said advertisements, two (2) interested bidders bought bidding documents for the Project, namely:

- Ecosystem Technologies International Inc.; and
- CrediBuild Development Corporation;

**WHEREAS**, pursuant to the aforesaid invitation, a public bidding was held on March 15, 2023, wherein two (2) bidders, **Ecosystem Technologies International Inc.** and **Credibuild Development Corporation**, submitted their bids;

**WHEREAS**, during the preliminary examination of bids, the BAC, using a non-discretionary “pass/fail” criteria, determined the bid of **Credibuild Development Corporation** as “passed” for complying with the eligibility and technical requirements as stated in the Bidding Documents while the bid of **Ecosystem Technologies International Inc.** as “non-complying” for non-submission of list of Contractors, Key Staff, Partners or Principal Officers, Design and Construction Personnel to be assigned to the contract to be bid;

**WHEREAS**, **Ecosystem Technologies International Inc.** did not file a motion for reconsideration within the required period despite being notified;

**WHEREAS**, the second envelope that contained the financial proposal of **Credibuild Development Corporation** that “passed” the preliminary examination of the eligibility/technical requirements was thereafter opened on April 5, 2023 and subjected to a preliminary evaluation;



**WHEREAS**, after evaluation of financial proposal, the Bids and Awards Committee declared the bid of **Credibuild Development Corporation** as the Single Calculated Bid in the amount of **PhP 192,714,385.06**;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Credibuild Development Corporation**, by way of post qualification, the Bids and Awards Committee found that its bid passed all the criteria and was thus declared as the Single Calculated and Responsive Bid for PR No. 22-4106 in the amount of **One Hundred Ninety Two Million Seven Hundred Fourteen Thousand Three Hundred Eighty Five Pesos and 00/100, Philippine Currency (PhP 192,714,385.00)**;


**NOW THEREFORE**, the members of the Bids and Awards Committee, in regular session assembled:







**NOW THEREFORE**, the members of the Bids and Awards Committee, in regular session assembled:




