



BAC RESOLUTION NO. 2023-350 A-DGP

"A RESOLUTION AWARDING PURCHASE REQUEST NO. 23-1554-
LOT 2 TO EURE'S PLANT NURSERY AND AGRI TRADING"

WHEREAS, the Provincial Government of Pampanga published in accordance with law an invitation to bid for **P.R. # 23-1554 – Lot 1 – Supply and delivery of Agricultural Equipment** with an approved budget for the contract in the amount of Six Hundred Sixty Three Thousand Pesos, Philippine Currency (PhP 663,000.00) and **P.R. # 23-1554 – Lot 2 – Supply and Delivery of Agricultural Supplies/Materials** with an approved budget for the contract in the amount of Four Hundred Twenty Five Thousand Five Hundred Sixty Five Pesos, Philippine Currency (PhP 425,565.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on April 26, 2023, wherein only one bidder, **Eure's Plant Nursery & Agri Trading** submitted its bids for Lot 1 and Lot 2 which when opened revealed to be compliant with the eligibility and technical requirements as stated in the Bidding Documents using a non-discretionary "pass/fail" criteria;

WHEREAS, the post-qualification evaluation of the bids resulted in the following:

- (a) For Lot 1, the bid of **Eure's Plant Nursery and Agricultural Trading** was found to be non-complying on the following ground:
- (1) Non-complying due to failure on Single Largest Completed Contract (SLCC) based on ITB Clause 5.3 and Bid Data Sheet.
- (b) For lot 2, the bid of **Eure's Plant Nursery and Agricultural Trading** was found responsive and was declared as the Single Calculated Bid. The same was forwarded to the TWG for post-qualification evaluation.

WHEREAS, the Committee instructed the Secretariat to inform **Eure's Plant Nursery and Agricultural Trading** of its non-compliance for Lot 1;

WHEREAS, **Eure's Plant Nursery and Agricultural Trading** did not file a Motion for Reconsideration within the required period for Lot 1;

WHEREAS, after careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Eure's Plant Nursery and Agricultural Trading** by way of post-qualification, the BAC found that its bid has passed all the criteria and was thus declared as the Single Calculated and Responsive Bid for Lot 2, in the amount of **Four Hundred Eighteen Thousand Nine Hundred Fifty Five Pesos, Philippine Currency (PhP 418,955.00)** for Lot 2;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:

RESOLVED, as it is hereby resolved, to recommend the award of the contract to **Eure's Plant Nursery and Agricultural Trading,** in the amount of **Four Hundred Eighteen Thousand Nine Hundred Fifty Five Pesos, Philippine Currency (PhP 418,955.00)** for Lot 2 in accordance with R.A. No. 9184 and its Revised IRR;


RESOLVED FURTHER, to submit the foregoing recommendation to the Head of the Procuring Entity (HOPE) for approval.
