



## CONTRACT FOR INFRASTRUCTURE

WHEREAS, the Entity is desirous that the Contractor execute **(To supply labor, materials and necessary equipment for the Concreting of Farm to Market Road at San Juan Baño, Arayat, Pampanga. (Re-bidding))** (hereinafter called "the Works") and the Entity has accepted the Bid for **(Five Million Thirty Seven Thousand Three Pesos and 07/100, Philippine Currency (Php 5,037,003.07))** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

In consideration for the sum of **(Five Million Thirty Seven Thousand Three Pesos and 07/100, Philippine Currency (Php 5,037,003.07))** or such other sums as may be ascertained, **GEOHEART CONSTRUCTION AND TRADING** agrees **To supply labor, materials and necessary equipment for the Concreting of Farm to Market Road at San Juan Baño, Arayat, Pampanga. (Re-bidding)** in accordance with its Bid.
