

5. The Province will hold a Pre-Bid Conference on **August 4, 2023 (Friday), 10:00 A.M.** at the **Bids and Awards Committee (BAC) Session Hall, Ground Floor, Provincial Capitol, City of San Fernando, Pampanga**, which shall be open to prospective bidders.
6. Bids must be duly received by the **Bids and Awards Committee (BAC) Secretariat Office** thru manual submission at **Ground Floor, Provincial Capitol, City of San Fernando, Pampanga** on or before **8:30 A.M. of August 16, 2023 (Wednesday)**. Late bids shall not be accepted.
7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
8. Opening of bids will be on **August 16, 2023 (Wednesday), 10:00 A.M.** at the **Bids and Awards Committee (BAC) Session Hall, Ground Floor, Provincial Capitol, City of San Fernando, Pampanga**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the activity.
