WHEREAS, the Entity is desirous that the Contractor execute – (To supply labor, materials and necessary equipment for the Improvement/ Concreting of Barangay Road at San Isidro, Sta. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
