



THIS AGREEMENT, made this \_\_\_\_\_ day of 03 NOV 2023, 2023 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **IZZO INDUSTRIAL SUPPLY** ( hereinafter called the "Supplier").




