**"A RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT TO TSD TRADING FOR PURCHASE REQUEST NO. 23-4693 THROUGH REPEAT ORDER"**

**WHEREAS**, the Provincial General Services Office requested for Purchase Request No. 23-4693 for 1,250 cases of Sardines and Tomato Sauce and 2,604 cases of Canned Shredded Beef with an Approved Budget for the Contract in the amount of PhP 8,311,555.00;

**WHEREAS**, the said purchase request and its attachment were referred to the Technical Working Group for evaluation and comment if the same may be procured through Repeat Order;

**WHEREAS**, in its letter dated November 30, 2023, the Technical Working Group opined that Repeat Order may be resorted to by a Procuring Entity if the following conditions are satisfied:

1. Repeat Order is provided in the Annual Procurement Plan as one of the alternative methods of procurement;
2. The original contract must have been procured through competitive bidding;
3. Contract prices of the repeat order are the same as or lower than those in the original contract, provided such prices are still the most advantageous to the government after price verification;
4. The repeat order will not result in splitting of contracts, requisitions or purchase orders;
5. Except in cases duly approved by the GPPB, the repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed (NTP) arising from the original contract;

In order not to exceed the 25% threshold, the goods under the original contract must be:

- i. Quantifiable
- ii. Divisible; and
- iii. Consisting of at least four (4) units per item

**WHEREAS**, based on the above, the TWG recommended the procurement of P.R. No. 23-4693 through Repeat Order;

**WHEREAS**, Section 51 of the Revised Implementing Rules and Regulations of R.A. 9184 authorizes resorting to Repeat Order from the previous winning bidder "whenever there is a need to replenish goods procured under a contract previously awarded through competitive bidding" provided that the conditions imposed therein are met;

**RESOLVED**, as it is hereby **RESOLVED**, to recommend the award of the contract through **Repeat Order** to **TSD Trading** for **Purchase Request No. 23-4693** for 1,250 cases of Sardines and Tomato Sauce and 2,604 cases of Canned Shredded Beef with an Approved Budget of the Contract in the amount of PhP 8,311,555.00 pursuant to RA 9184 and its Revised IRR;
