**CONTRACT FOR INFRASTRUCTURE
(NP-EMERGENCY CASES)**

THIS AGREEMENT, made this _____ day of 13 FEB 2024 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **Prime Pave Construction and Asphalt Corporation** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **(To supply labor, materials and necessary equipment for the Asphalt Overlay of Mexico- Angeles Road (Divisoria Bridge including Approaches) at Divisoria, Mexico, Pampanga)** (hereinafter called "the Works") and the Entity has accepted the Bid for **(One Million Three Hundred Eighteen Thousand Two Hundred Fifty Seven Pesos and 58/100, Philippine Currency (PhP 1,318,257.58))** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
