



WHEREAS, the Provincial Government of Pampanga has invited Organized Community or Social Groups (CSGs) of known qualifications for proposals covering the project for **Purchase Request No. 23-4556 – Seedling Production at the Provincial Seedling Nursery at the Provincial Material Recovery Facility (MRF) in Porac, Pampanga through Community Participation** with an approved budget for the contract in the amount of Nine Hundred Eighty Five Thousand Pesos, Philippine Currency (Php 985,000.00);

WHEREAS, RFQ No. 240025 was posted in the PhilGEPS on January 16, 2024, the website of the provincial government and its premises, in conspicuous places where the project will be implemented, and three CSGs from the community where the project will be implemented were likewise invited to submit their quotations, namely, **Dolorians Agriculture Cooperative, Ilug Kamalig Agriculture Cooperative and Mitla Farmers Agriculture Cooperative;**

WHEREAS, on the scheduled opening of quotations on January 24, 2024, only the **Ilug Kamalig Agriculture Cooperative** submitted its quotation which when opened was found to be non-complying for insufficient requirements and the said purchase request was returned to the end user for evaluation;

WHEREAS, in a letter dated January 29, 2024, the end user requested for the reposting of the said purchase request which was approved by the Committee under BAC Resolution No. 033 dated January 31, 2024;

WHEREAS, based on the said resolution, RFQ No. 240025 was reposted in the PhilGEPS on February 5, 2024, in other areas as required, and three CSGs from the community where the project will be implemented were again invited to submit their quotations, namely, **Dolorians Agriculture Cooperative, Ilug Kamalig Agriculture Cooperative and Mitla Farmers Agriculture Cooperative;**

WHEREAS, on the scheduled opening of quotations on February 14, 2024 only the **Ilug Kamalig Agriculture Cooperative** submitted its quotation;

WHEREAS, after the preliminary examination of the quotation, using a non-discretionary "pass/fail" criteria, the BAC determined the submission of the **Ilug Kamalig Agriculture Cooperative** as "passed" for complying with all the eligibility and technical requirements as stated in the Invitation for Negotiated Procurement;


