

No. 24-0830 — To supply labor, materials and necessary equipment for the Rehabilitation/ Improvement of Sta. Ana-Magalang Road (San Roque- San Pablo Section) at San Roque and San Pablo, Sta. Ana, Pampanga with an approved budget for the contract in the amount of Twenty Nine Million Nine Hundred Thirty Thousand Four Hundred Eighty Six Pesos and 09/100 Philippine Currency (PhP 29,930,486.09);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on May 3, 2024, wherein two (2) bidders, Positive Builders and Trading and Bungamatahari Construction, submitted their bids;
