WHEREAS, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for **P.R. # 24-0768 – Supply and delivery of various Packed Meals** which is composed of the following:

Lot 1 - Packed Meals	ABC PhP 1,080,000.00
Lot 2 - Full Catering Service	ABC PhP 1,100,000.00

with a total approved budget for the contract in the amount of PhP 2,180,000.00;

WHEREAS, during the submission and opening of bids on April 03, 2024, only one (1) bidder, Stella’s Events and Management Services submitted bids for Lot 1 and Lot 2;

WHEREAS, after preliminary examination of the bids for Lot 1 and Lot 2, the BAC, using non-discretionary “pass/fail” criteria determined the submission of Stella’s Events Management Services as “**passed**” for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after the detailed evaluation of the bids, the BAC determined the following:

WHEREAS, based on the above evaluation, the BAC declared the bids of Stella's Events Management Services in the amount of PhP 1,080,000.00 (Lot 1) and PhP 1,100,000.00 (Lot 2), respectively, as the Single Calculated Bids;

WHEREAS, upon careful examination, validation and verification of all statements made and documents submitted by **Golden Leaf Nursery**, as stated in the bidding documents, the BAC found that its respective bids for Lot 1 and Lot 2 passed all criteria for post-qualification;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled, **RESOLVED**, as it is hereby resolved, the following:
