

Contract Agreement

THIS AGREEMENT, made this 05 day of July, 2024 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **MAJR ENTERPRISES, INC.** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply and delivery of Reagents for Mindray BC-32 Hematology Analyzer, Mindray BS-240 Fully Automated Chemistry Analyzer and Mindray BC-3000 Hematology Analyzer] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [**Eleven Million Five Hundred Forty Eight Thousand Nine Hundred Thirty Six Pesos and 00/100 (Php 11,548,936.00)**] (hereinafter called "the Contract Price").




