**INVITATION FOR COMPARATIVE PROPOSALS FOR  
THE PAMPANGA DIALYSIS NETWORK**

The Provincial Government of Pampanga invites local and international companies to submit comparative proposals under a Comparative Challenge Bidding Process for the operation and maintenance of the Pampanga Dialysis Network (the "Project") located in the Municipality of Guagua, within the compound of Diosdado P. Macapagal Memorial Hospital and in the Municipality of Apalit, in the Province of Pampanga for a term of five (5) years.

The comparative bidding for the Project will be conducted in accordance with the procurement rules and procedures applicable to unsolicited proposals set out in the PPP Code.

The Province invites interested private sector proponents/participants (PSPs) to submit comparative proposals under a Swiss Challenge Bidding Process to operate and maintain the Project for five (5) years from the date the center starts its operation, renewable upon mutual agreement.

The minimum investment commitment for the Project is PhP 729,957,535.00.

The competitive bidding for the Project will be conducted in accordance with the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 11966, also known as the Public-Private Partnership (PPP) Code of the Philippines.

A Single-Stage Qualification and Bidding for this Project shall be conducted pursuant to and in accordance with Section 9 of RA 11966.

In the event that a comparative proponent submits a bid proposal better than those submitted by the Original Proponent, the Original Proponent shall have the "right-to-match" the best offer or such proposal, in accordance with Section 98 of the IRR of RA 11966.

**Swiss Challenge Documents** will be available on **08 August 2024 between 8:00 AM to 5:00 PM until 09:00 AM of 07 November 2024** at the **Bids and Awards Committee (BAC) Secretariat Office, Ground Floor, Provincial Capitol, City of San Fernando, Pampanga.**

Prospective comparative proponents must pay a non-refundable fee of One Hundred Thousand Philippine Pesos, (Php 100,000.00), payable in cash or manager's check drawable from any Land Bank of the Philippines and payable to the order of "**Provincial Government of Pampanga**" at the **Provincial Treasurer's Office** and submit the following documentary requirements:

- a. An expression of Interest;
- b. A letter appointing an Authorized Representative to execute a non-disclosure; and
- c. A duly executed Non-Disclosure Agreement.

The schedule for the **Submission and Opening** of the Comparative Proposal shall be as follows:



A **Pre-Bid Conference** shall be conducted by the **PPP-Pre-qualification/Qualification BAC on 22 August 2024, 10:00 AM at the Old SP Session Hall, Second Floor, Provincial Capitol, City of San Fernando, Pampanga. Please note that only those who paid for the Tender Documents will be invited to attend the Pre-Bid Conference.**

The Province reserves the right to reject, at any time prior to the signing of the JV agreement, any or all proposals without thereby incurring any liability to the affected PSPs, to waive any minor defects therein, and to accept the offer that it deems most advantageous to the Philippine government. The Province also reserves the right to reject any or all comparative proposals, and other relevant tender or bidding documents, declare a failure of bidding, and not award the contract for any justifiable and reasonable ground when an award will not benefit the Province, without thereby any liability to the affected proponent(s) or bidder(s).
