

Contract Agreement

THIS AGREEMENT, made this _____ day of 08 AUG 2024, 2024 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **DIEGO MERCH SPECIALIZED GOODS TRADING** (hereinafter called the "Supplier").


