"A RESOLUTION AWARDING PURCHASE REQUEST NO. 24-1767-TO TSD TRADING"

WHEREAS, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for P.R. # 24-1767 – Supply and Delivery of Canned Goods (Single Year Framework Agreement) with an approved budget for the contract in the amount of Fifty Four Million Nine Hundred Sixty Eight Thousand Seven Hundred Fifty Pesos, Philippine Currency (PhP 54,968,750.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on June 14, 2024, wherein only one bidder, TSD Trading, submitted its bid;

WHEREAS, the BAC-TWG determined the submission of the abovecited bidder as "passed" for complying with all the eligibility and technical requirements using a non-discretionary "pass/fail" criteria as stated in the bidding documents after the preliminary examination of bid;

WHEREAS, the Bids and Awards Committee declared the bid of TSD Trading as the Single Calculated Bid in the amount of PhP 54,965,000.00 after the detailed evaluation of the bid;

WHEREAS, upon careful examination, validation and verification of all statements made and documents submitted, the BAC-TWG found that the submission of TSD Trading passed all criteria for post-qualification and recommended the award of the contract in its favor which was adopted by the committee;

NOW THEREFORE, the Bids and Awards Committee, in regular session, RESOLVED, as it is hereby resolved, the following:

- 1) To declare the bid of TSD Trading in the amount of Fifty Four Million Nine Sixty Five Thousand Pesos, Philippine Currency 54,965,000.00) as the Single Calculated and Responsive Bid in accordance with Section 36 of the Updated RIRR of RA 9184:
- 2) To recommend the award of the contract to the TSD Trading abovementioned amount in accordance with Section 37.1 of the same RIRR.

FRAMEWORK AGREEMENT

Project Title - Supply and Delivery of Canned Goods

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into by and between [PROVINCIAL GOVERNMENT OF PAMPANGA] of the Philippines with office address at <u>Capitol Compound</u>, <u>Barangay Sto. Nino</u>, <u>City of San Fernando</u>, <u>Pampanga</u> represented herein by <u>DENNIS G. PINEDA</u>, <u>Provincial Governor</u> and hereafter referred to as the "PROCURING ENTITY".

and

[TSD TRADING], a duly registered entity existing under the laws of the Philippines with postal address at <u>San Vicente</u>, <u>Apalit</u>, <u>Pampanga</u> represented by its <u>Owner/General Manager</u>, <u>Mrs. TEODORA S. DALISAY</u> hereinafter referred to as the "THE SUPPLIER",

WITNESSETH, that:

WHEREAS, THE PROCURING ENTITY decided to use Framework Agreement on its procurement project <u>Supply and Delivery of Canned Goods</u> (Single Year Framework Agreement);

WHEREAS, this Agreement is for the option to purchase of goods determined to be necessary and desirable to address and satisfy the needs of THE PROCURING ENTITY but by its nature, use of characteristic, the quantity and/or exact time of need cannot be accurately pre-determined.

WHEREAS, THE PROCURING ENTITY has the option to purchase the items provided in the Framework Agreement List, attached and made an integral part of this Agreement as provided in Article I, on a date and time to be determined in the Call-Off to be issued for such purpose by THE PROCURING ENTITY; and

WHEREAS, THE SUPPLIER which passed the eligibility screening conducted by THE PROCURING ENTITY, shall maintain and update the eligibility requirements during period of this Agreement and shall honor all obligation under this Framework Agreement.





Article I GENERAL CONSIDERATIONS


- This Framework Agreement is an option contract. THE PROCURING ENTITY is given
 the option to either purchase the identified items in the Framework Agreement or not to
 purchase at all. The discretion to exercise the option falls solely with THE PROCURING
 ENTITY, THE SUPPLIER may not require or demand for the latter to purchase the items
 in the Framework Agreement List.
- 2. In this Framework Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract which is attached thereto and made and made an integral part thereof.
- 3. The following documents shall be deemed to form and be read and construed as part of this Agreement:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Framework Agreement List and the Technical Specifications;
 - (c) the General Conditions of Contract;
 - (d) the Special Conditions of Contract;
 - (e) the Performance Security or Performance Securing Declaration;
 - (f) the Procuring Entity's Notice to Execute Framework Agreement;
 - (g) Mini Competition, when necessary; and
 - (h) Call-Offs.

Article II DURATION

The term of this Agreement shall be one (1) year from the date of execution unless sooner revoked by both parties.

Article III CONSIDERATION

For the consideration of one peso (Php 1.00), THE PROCURING ENTITY have the option to purchase any or all of the items in the Framework Agreement List through the Issuance of Call-Off and THE SUPPLIER commits to deliver the goods and perform the services subject to the conditions of the Call-Off.



The Framework Agreement being an option contract, a procurement contract is perfected only when THE PROCURING ENTITY exercises the option to procure any item from the Framework Agreement List through the issuance of a Call-Off.

Article V OBLIGATION TO ANSWER A CALL-OFF

Once THE PROCURING ENTITY issues a Call off THE SUPLIER is bound to deliver the goods or perform the services identified as the time and date specified in the Call-Off.

Failure on the part of THE SUPPLIER to deliver goods or perform the services shall warrant forfeiture of performance security or performance securing declaration and imposition of liquidated damages as provided for the Guidelines on the use of Framework Agreement by all Procuring Entities without prejudice to all other applicable sanctions.

Article VI TERMS AND CONDITIONS

The terms and conditions of this Framework Agreement shall be governed by Guidelines on the Use of Framework Agreement by all Procuring Entity and all relevant issuance of the GPPB.
