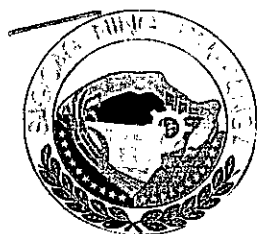

**"A RESOLUTION AWARDING PURCHASE REQUEST NO. 24-1637-
 TO KARPAM GENERAL MERCHANDISE"**

WHEREAS, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for **P.R. # 24-1637 – Supply and Delivery of 20,000 cavans – Well-Milled Commercial Rice (Single Year Framework Agreement)** with an approved budget for the contract in the amount of **Seventy Million Pesos, Philippine Currency (PhP 70,000,000.00)**;

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on June 14, 2024 wherein two (2) bidders, namely: **Maunlad Ricemill Corporation** and **Karpam General Merchandise** submitted their bids;

WHEREAS, after preliminary examination of the bids, the BAC, using non-discretionary "pass/fail" criteria, determined the following:

1. The submission of **Karpam General Merchandise** as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents; and
2. The submission of **Maunlad Rice Mill Corporation** as "failed" for failure to sign the first page of the Bid Form (per GPPB Resolution No. 16-2020 Appendix "1" Bid Form for the Procurement of Goods – failure to sign in each and every page of the Bid Form shall be a ground for the rejection of the bid);

WHEREAS, the representative of the **Maunlad Rice Mill Corporation** was notified in open session that a Motion for Reconsideration may be filed for the Committee's declaration of non-compliance of the company's submitted bid;

WHEREAS, on June 18, 2024, **Maunlad Rice Mill Corporation** filed a Motion for Reconsideration but was denied by the Committee in its Resolution No. 2024-174-DGP dated June 21, 2024, and the said bidder was notified of the denial of its motion for reconsideration;

WHEREAS, after the detailed bid evaluation, the BAC declared the submission of **Karpam General Merchandise** as the Single Calculated Bid in the amount of PHP 51,750,000.00;

WHEREAS, in accordance with Section 55 of the Updated 2016 RIRR of RA 9184, **Maunlad Rice Mill Corporation** has seven (7) calendar days to protest the BAC's decision;

WHEREAS, **Maunlad Rice Mill Corporation** did not file a protest within the required period;

WHEREAS, after careful examination, validation and verification of all statements made and documents submitted by **Karpam General Merchandise** as stated in the Bidding Documents, the the BAC found that its bid passed all criteria for postqualification.

NOW, THEREFORE, the Bids and Awards Committee, in regular session, **RESOLVED**, as it is hereby resolved, the following:

1) To declare the bid of the **Karpam General Merchandise** in the amount of **Sixty Nine Million Pesos (PHP69,000,000.00.00)** as the Single Calculated and Responsive Bid in accordance with Section 36 of the Updated RIRR of RA 9184 in relation to Appendix 32 Section 7.4.3 of the Guidelines on the Use of Framework Agreement by All Procuring Entities;

2) To recommend the award of the contract to **Karpam General Merchandise** in the abovementioned amount in accordance with the same Guidelines.

RESOLVED FURTHER, to submit the foregoing recommendations to the Head of the Procuring Entity (HOPE) for approval.



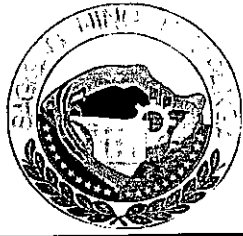


