

THIS AGREEMENT, made this _____ day of _____, 2024 between the **PROVINCIAL GOVERNMENT OF PAMPANGA** hereinafter called the "Entity" and **FEDERATION OF SASMUAN FISHERFOLKS ASSOCIATION, INC.** hereinafter referred to as the "Community or Group" or "CSG" for brevity;
