

Contract Agreement

THIS AGREEMENT, made this _____ day of _____, 2024 between PROVINCIAL GOVERNMENT OF PAMPANGA (hereinafter called the "Entity") and MEDICEL ENTERPRISES (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply, Delivery and Installation of Endoscopy Tower Upgrade System with Electrosurgical Generator and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(Nineteen Million Nine Hundred Ninety Two Thousand Eight Hundred Eighty Pesos, Philippine Currency (PhP 19,992,880.00)] (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii .General and Special Conditions of Contract; and
 - iv. Supplemental /Bid Bulletins, if any;
 - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security;
- (d) Notice of Award of Contract and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Nineteen Million Nine Hundred Ninety Two Thousand Eight Hundred Eighty Pesos, Philippine Currency (PhP 19,992,880.00) or such other sums as may be ascertained, MEDICEL ENTERPRISES agrees to the Supply, Delivery and Installation of Endoscopy Tower Upgrade System with Electrosurgical Generator in accordance with its Bid.

4. The PROVINCIAL GOVERNMENT OF PAMPANGA agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
