



THIS AGREEMENT, made this _____ day of 02 SEP 2024, 2024 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **OCEANLINK MARKETING CORPORATION** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply and delivery of Fortified Rice Porridge & Powdered Milk Drink] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(Five Million Eight Hundred Seventeen Thousand Pesos, Philippine Currency (PhP 5,817,000.00)) (hereinafter called "the Contract Price").
