KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into by and between [PROVINCIAL GOVERNMENT OF PAMPANGA], with office address at Capitol Compound, Barangay Sto. Nino, City of San Fernando (P), represented herein by DENNIS G. PINEDA, Provincial Governor and hereafter referred to as the "PROCURING ENTITY".

FRANCIS CAMPANA, hereinafter referred to as the "THE SUPPLIER",

WITNESSETH, that:

WHEREAS, THE PROCURING ENTITY decided to use Framework Agreement on its procurement project **Supply and Delivery of various supplies and materials used for Repacking of Goods (Single Year Framework Agreement)**;
