**Dear Mr. Paglicawan:**

We formally notify you that on 22 November 2024, the resolution of the Public-Private Partnership Pre-Qualification/Qualification Bids and Awards Committee ("**PPP-PBAC**") recommending the award of the contract for the Operation and Maintenance of the Pampanga Dialysis Network Project located in the Municipality of Guagua, within the compound of Diosdado P. Macapagal Memorial Hospital and in the Municipality of Apalit ("**the Project**"), with a total Project Cost of **Seven Hundred Twenty-Nine Million Nine Hundred Fifty-Seven Thousand Five Hundred Thirty - Five Philippine Pesos (PHP 729,957,535.00)**, in favor of B. Braun Avitum Philippines, Inc. **WAS APPROVED.**

In accordance with Republic Act No. 11966, otherwise known as the Public-Private Partnership Code of the Philippines ("**PPP Code**"), and its Implementing Rules and Regulations ("**IRR**"), and pursuant to the Instructions to Comparative Proponents issued for the Project, we are issuing this Notice of Award ("**NOA**") of even date to the Original Proponent.

Accordingly, you are hereby **required to conform** to this NOA by affixing your name and signature on the space provided below and return the same to the PPP-PBAC **within twenty (20) calendar days from official receipt of this NOA** with the following documents ("**Post-Award Requirements**"):

1. NOA conformed to, and signed by, the authorized representative of Original Proponent;
2. Duly Notarized Board Resolution and Secretary Certificate submitting the amount of the Bid Bond to constitute as its Performance Security, subject to


execution and submission of necessary requirements for this purpose before the Office of the Provincial Treasurer's Office; and

3. Letters from reputable financial institutions expressing their willingness to provide sufficient credit facilities as required in the Winning Proponent's Financial Proposals and also indicating the terms and conditions for such facilities.

Please be reminded that **failure by the Original Proponent to comply with the requirements described herein within twenty (20) calendar days** from receipt of this NOA, or within any extensions granted by the PPP-PBAC, without reasonable justification acceptable to the Province, shall result in the **forfeiture of the Original Proponent's Bid Security and the withdrawal of this NOA.**

Within five (5) calendar days from receipt of the requirements in this NOA, the Governor shall determine compliance with all of the requirements stated in this NOA, and notify the Original Proponent thereafter for its guidance.
