In consideration for the sum of **One Million Seven Hundred Ninety Seven Thousand Pesos, Philippine Currency (PhP 1,797,000.00)** or such other sums as may be ascertained, **LGY TRADING** agrees to the supply and delivery of **3,000 pcs. Book Cover with Chicago Screws** in accordance with its Bid.


