## BIDS AND AWARDS COMMITTEE BAC RESOLUTION NO. 2024-\_\_830\_\_-DGP

"A RESOLUTION RECOMMENDING THE AWARD OF P.R. NO. 24-4704 TO TSD TRADING"

WHEREAS, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for P.R. No. 24-4704 - Supply and delivery of 2,250 cases Sardines in Tomato Sauce and 4,688 cases Canned Shredded Beef with an approved budget for the contract in the amount of Sixteen Million Four Hundred Ninety One Hundred Thousand Seven Hundred Pesos, Philippine Currency (Php 16,491,700.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on October 16, 2024 wherein three (3) bidders, namely: G-Well General Merchandise, Fortune Group Corporation and TSD Trading submitted their bids;

WHEREAS, the BAC TWG determined the submissions of the abovecited bidders as having "passed" all the eligibility and technical requirements as stated in the bidding documents using a non-discretionary "pass/fail" criteria after the preliminary examination of bids;

WHEREAS, after the detailed examination of bids, the bids were ranked to identify the lowest calculated bid, as follows:

1. Fortune Group Corporation

- P 9,067,992.00

2. G-Well General Merchandise

- P 16,457,010.00

3. TSD Trading

- P 16,489,450.00

WHEREAS, the Bids and Awards Committee accordingly declared the bid of Fortune Group Corporation as the Lowest Calculated Bid in the amount of P9,067,992.00;

WHEREAS, after postqualification evaluation, the BAC TWG determined that the submission of Fortune Group Corporation failed to comply with the Technical Specifications particularly on the sodium content and with the Schedule of Requirements particularly on the required stocks inventory and was therefore postdisqualified;

WHEREAS, Sections 34.5 and 34.6 of the Updated RIRR of RA 9184 provide that if the BAC determines that the bidder with the lowest calculated bid fails the criteria for post-qualification, it shall immediately notify the bidder in writing of its post disqualification and the grounds for it and notwithstanding any pending request for reconsideration thereof, the BAC shall initiate and complete the same post-qualification process on the bidder with the second lowest calculated bid;

WHEREAS, the Committee instructed the Secretariat to notify the bidder of its post-disqualification and the reasons therefor and without prejudice to the right of Fortune Group Corporation to file a motion for reconsideration, instructed the TWG to initiate the post-qualification evaluation on the next ranked bidder, G-Well General Merchandise;

WHEREAS, the Fortune Group Corporation did not file a motion for reconsideration within the reglementary period;

WHEREAS, after post-qualification evaluation, the BAC TWG determined that the submission of G-Well General Merchandise failed to comply with the requirements in the Bid Data Sheet particularly ITB Clause 20 -submission of authorized dealer/manufacturer to assure product quality and availability and with the Schedule of Requirements particularly on the required stocks inventory and was therefore post-disqualified;

WHEREAS, the Committee instructed the Secretariat to notify the bidder of its post-disqualification and the reasons therefor and without prejudice to the right of G-Well General Merchandise to file a motion for reconsideration, instructed the TWG to initiate the post-qualification evaluation on the next ranked bidder, TSD Trading;

WHEREAS, the G-Well General Merchandise did not file a motion for reconsideration within the reglementary period;

WHEREAS, after careful examination, validation and verification of all statements made and documents submitted, as stated in the bidding documents, the BAC-TWG found that the submission of TSD Trading passed all criteria for postqualification and recommended the award of the contract in its favor;

NOW, THEREFORE, the Members of the Bids and Awards Committee, in regular session RESOLVED, as it is hereby resolved, the following:

- 1) To declare the bid of TSD Trading in the amount of Sixteen Million Four Hundred Eighty Nine Thousand Four Hundred Fifty Pesos (P16,489,450.00) as the Lowest Calculated and Responsive Bid in accordance with Section 34.4 in relation to Section 34.7 of the Updated RIRR of RA 9184;
- 2) To recommend the award of the contract to **TSD Trading** in the abovementioned amount in accordance with Section 37.1 of the same IRR.

**RESOLVED FURTHER**, to submit the foregoing recommendations to the Head of the Procuring Entity (HoPE) for approval.
