BAC RESOLUTION NO. 2024- 777-C -A-DGP

"A RESOLUTION RECOMMENDING THE AWARD OF PURCHASE REQUEST NO. 24-4313 TO EPP FIRE SAFETY AND RESCUE PRODUCTS CO."

WHEREAS, the Provincial Government of Pampanga published in accordance with Republic Act 9184 and its Updated Revised Implementing Rules and Regulations an invitation to bid for **P.R. # 24-4313 - Supply and Delivery of Various Rescue Tools and Equipment (Re-bidding)** with an Approved Budget for the Contract (ABC) in the amount of Two Million Five Hundred Fifty Thousand and One Hundred Pesos, Philippine Currency (PhP 2,550,100.00);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on October 9, 2024, wherein only one (1) bidder, **EPP Fire Safety and Rescue Products Co.** submitted its bid;

WHEREAS, during the preliminary examination of bids, the Bids and Awards Committee – Technical Working Group (BAC-TWG) using a non-discretionary "pass/fail" criteria, determined the submission of **EPP Fire Safety and Rescue Products Co.** as "failed" due to non-compliance of its submitted After Sales Requirement with the technical requirements as stated in the bidding documents;

WHEREAS, the supplier's representative manifested in an open session that it will not file a Motion for Reconsideration;

WHEREAS, the end-user likewise requested in an open session the re-bidding of the items without changes in the ABC, Technical Specifications and Terms of Reference as these are part of their Dream Marker project and other activities of the Provincial Disaster Risk Reduction and Management Office (PDRRMO) this coming December;

WHEREAS, based on the above manifestations, the BAC in its Resolution No. 281-DGP dated October 9, 2024 declared a failure of bidding for PR No. 24-4313 and its re-bidding thereof;

WHEREAS, the Second Invitation to Bid was published on October 10, 2024;

WHEREAS, during the scheduled opening of bids on October 30, 2024, only one (1) bidder, **EPP Fire Safety and Rescue Products Co.** submitted its bid;

WHEREAS, the BAC-TWG determined the submissions of the aforementioned bidder as "passed" for complying with all the eligibility and technical requirements using

a non-discretionary "pass/fail" criteria as stated in the bidding documents after the preliminary examination of bid;

WHEREAS, the Bids and Awards Committee declared the bid of **EPP Fire Safety and Rescue Products Co.** as the Single Calculated Bid in the amount of Two Million Five Hundred Forty-Five Thousand and One Hundred Pesos, Philippine Currency (PhP 2,545,100.00) after the detailed evaluation of the bid;

WHEREAS, upon careful examination, validation and verification of all statements made and documents submitted, the BAC-TWG found that the submission of **EPP Fire Safety and Rescue Products Co.** passed all criteria for post-qualification and recommended the award of the contract in its favor which was adopted by the Committee;

NOW THEREFORE, the Bids and Awards Committee in regular session:

RESOLVED, as it is hereby resolved, the following:

- 1) To declare the bid of **EPP Fire Safety and Rescue Products Co.** in the amount of **Two Million Five Hundred Forty-Five Thousand and One Hundred Pesos, Philippine Currency (PhP 2,545,100.00)** as the Single Calculated and Responsive Bid in accordance with Section 36 of the Updated RIRR of RA 9184; and
- 2) To recommend the award of the contract to the **EPP Fire Safety and Rescue Products Co.** in the abovementioned amount in accordance with Section 37.1 of the Updated RIRR of RA 9184.


RESOLVED FINALLY, to submit the foregoing recommendations to the Head of the Procuring Entity (HoPE) for approval.




