

THIS AGREEMENT, made this _____ day of 06 JAN 2025, 2025 between **PROVINCIAL GOVERNMENT OF PAMPANGA** (hereinafter called the "Entity") and **GOLDEN LEAF NURSERY** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply and Delivery of 5,761 bags – Certified Organic Fertilizer (50kg./bag)] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(Two Million Four Hundred Nineteen Thousand Forty Three Pesos & 90/100, Philippine Currency (PhP 2,419,043.90)) (hereinafter called "the Contract Price")].
