**"A RESOLUTION AWARDING PURCHASE REQUEST NO. 24-5835 TO KONA HEALTHCARE, INC."**

**WHEREAS**, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for **P.R. # 24-5835 – Supply, Delivery and Installation of Medical & Dental Equipment** with an approved budget for the contract in the amount of Four Million Seven Hundred Fifty Thousand Pesos, Philippine Currency (PhP 4,750,000.00);

**WHEREAS**, pursuant to the aforesaid invitation, a public bidding was held on December 12, 2024, wherein three (3) bidders, **Kona Healthcare, Inc., Tesoro Enterprises** and **Golden Solutions Consumer Goods Trading**, submitted their bids;

**WHEREAS**, the BAC-TWG determined the submission of the abovesited bidders as having "passed" all the eligibility and technical requirements as stated in the bidding documents using a non-discretionary "**pass/fail**" criteria after the preliminary examination of bids;

**WHEREAS**, after detailed evaluation of the bids, the bids were ranked to identify the lowest calculated bid as follows:

Name of Bidder	Bids as Calculated
Kona Healthcare, Inc.	PhP 4,150,000.00
Tesoro Enterprises	PhP 4,230,000.00
Golden Solutions Consumer Goods Trading	PhP 4,745,000.00

**WHEREAS**, based on the above evaluation, the BAC declared the submission of **Kona Healthcare, Inc.** as the Lowest Calculated Bid in the amount of **PhP 4,150,000.00**;

**WHEREAS**, upon careful examination, validation and verification of all statements made and documents submitted, the BAC-TWG found that the submission of **KONA Healthcare, Inc.**, passed all criteria for post-qualification and recommended the award of the contract in its favor which was adopted by the committee;

**NOW THEREFORE**, the Bids and Awards Committee, in regular session, **RESOLVED**, as it is hereby resolved, the following:

- 1) To declare the bid of **KONA Healthcare, Inc.** in the amount of **Four Million One Hundred Fifty Thousand Pesos, Philippine Currency (PhP 4,150,000.00)** as the Lowest Calculated and Responsive Bid in accordance with Section 34.4 of the Updated RIRR of RA 9184;
- 2) To recommend the award of the contract to the **KONA Healthcare, Inc.** in the abovementioned amount in accordance with Section 37.1 of the same RIRR.


**RESOLVED FURTHER**, to submit the foregoing recommendations to the Head of the Procuring Entity (HOPE) for approval.




