Contract Agreement

THIS AGREEMENT, made this 6th day of FEBRUARY, 2025 between **PROVINCIAL GOVERNMENT OF PAMPANGA** with its principal office at Capitol Compound, City of San Fernando, Pampanga herein represented by its Governor, **DENNIS G. PINEDA** (hereinafter called the "Entity") and **KONA HEALTHCARE, INC.** with office address at San Vicente, Bacolor, Pampanga, herein represented by its Authorized Representative **NICOLIE DEO E. PASCUAL** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply, Delivery and Installation of Medical & Dental Equipment] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [**(Four Million One Hundred Fifty Thousand Pesos, Philippine Currency (PhP 4,150,000.00))**] (hereinafter (hereinafter called "the Contract Price").

 - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.



- (c) Performance Security;

In consideration for the sum of **Four Million One Hundred Fifty Thousand Pesos, Philippine Currency (PhP 4,150,000.00)** or such other sums as may be ascertained, **KONA HEALTHCARE, INC.** agrees to the **Supply, Delivery and Installation of Medical & Dental Equipment** in accordance with its Bid.

4. The **PROVINCIAL GOVERNMENT OF PAMPANGA** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
