THIS AGREEMENT, made this _____ day of <u>FEB 2 4 2025</u>2025 between **PROVINCIAL GOVERNMENT OF PAMPANGA** with its principal office at Capitol Compound, City of San Fernando, Pampanga herein represented by its Governor, **DENNIS G. PINEDA** (hereinafter called the "Entity") and **KONA HEALTHCARE**, **INC**. with office address at San Vicente, Bacolor, Pampanga, herein represented by its Authorized Representative **NICOLIE DEO E**. **PASCUAL** (hereinafter called the "Supplier").

THIS AGREEMENT, made this ______ day of <u>EB 2 4 2025</u>, 2025 between **PROVINCIAL GOVERNMENT OF PAMPANGA** with its principal office at Capitol Compound, City of San Fernando, Pampanga herein represented by its Governor, **DENNIS G. PINEDA** (hereinafter called the "Entity") and **PAMPANGA HOSPITAL PRODUCT** with office address at Purok 1, Brgy. Sta. Lucia, City of San Fernando, Pampanga, herein represented by its Owner and General Manager **ANTHONY G. CHIN** (hereinafter called the "Supplier").
