THIS AGREEMENT, made this ______ day of ______, 2025 between PROVINCIAL GOVERNMENT OF PAMPANGA with its principal office at Capitol Compound, City of San Fernando, Pampanga herein represented by its Governor, DENNIS G. PINEDA (hereinafter called the "Entity") and ITBS INFORMATION TECHNOLOGY BUSINESS SOLUTIONS CORPORATION with office address at Greenville Subd. Brgy. San Jose, City of San Fernando, Pampanga, herein represented by its Project Manager HARLENE E. GARCIA (hereinafter called the "Supplier").

WHEREAS, the Entity Invited Bids for certain goods and ancillary services, particularly [Supply, Delivery, Installation, Configuration, and Integration of Seamless LED Video Wall System & Upgrade of I.T. Equipment for the Pampanga Command & Control Center] and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(Twenty Four Million Nine Hundred Fifty Thousand Pesos, Philippine Currency (PhP 24,950,000.00)] (hereinafter called "the Contract Price").

 - iv. Supplemental /Bid Bulletins, if any;
 - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.

Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security;
- (d) Notice of Award of Contract and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
