



PINEDA** (hereinafter called the "Entity") and **ITBS INFORMATION TECHNOLOGY BUSINESS SOLUTIONS CORPORATION** with office address at Greenville Subd. Brgy. San Jose, City of San Fernando, Pampanga, herein represented by its Project Manager **HARLENE E. GARCIA** (hereinafter called the "Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply, Delivery, Installation, Configuration, and Integration of Seamless LED Video Wall System & Upgrade of I.T.   - (b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted.
