The Procuring Entity, *The Provincial Government of Pampanga* wishes to receive Bids for the Procurement of **Supply & Delivery of VARIOUS MEALS** for the with *Identification Number: Purchase Request No. 25 - 0352*.

The Procurement of **Supply & Delivery of VARIOUS MEALS** is composed of **One (1) Lot**, the details of which are described in **Section VII (Technical Specifications)**.

2. Funding Information

2.1. The Provincial Government of Pampanga through the source of funding as indicated below for **GENERAL FUND** in the amount of **Nine Million Six Hundred Thousand Pesos (Php 9,600,000.00)**.

2.2. The source of funding is **LGU's proposed Local Government Expenditure Program**.

3. Bidding Requirements
