

BIDS AND AWARDS COMMITTEE BAC RESOLUTION NO. 2025- A-142 - DGP

"A RESOLUTION RECOMMENDING THE AWARD OF P.R. NO. 25-0220 TO MAM CONSTRUCTION & TRADING"

WHEREAS, the Provincial Government of Pampanga published in accordance with RA 9184 and its Updated RIRR an invitation to bid for P.R. No. 25-0220 - To supply labor, materials and necessary equipment for the Improvement/Concreting of Barangay, Road at Anon, Floridablanca, Pampanga with an approved budget for the contract in the amount of Four Million Nine Hundred Ninety Eight Thousand Nine Hundred Sixty Five Pesos and 62/100 Philippine Currency (PhP 4,998,965.62);

WHEREAS, pursuant to the aforesaid invitation, a public bidding was held on February 11, 2025, wherein two (2) bidders, MAM Construction and Trading and Positive Builders and Trading, submitted their bids;

WHEREAS, the BAC-TWG determined the submission of the above cited bidders to have "passed" all the eligibility and technical requirements as stated in the bidding documents using a non-discretionary "pass/fail" criteria after the preliminary examination of the bids;

WHEREAS, after detailed evaluation of the bids, the bids were ranked to identify the lowest calculated bid as follows:

Name of Bidder	Bid Amount (As Calculated)	% Variance From ABC
1) MAM Construction and Trading	4,972,993.32	0.52
2) Positive Builders & Trading	4,978,793.19	0.40

WHEREAS, based on the above evaluation, the Bids and Awards Committee declared the bid of MAM Construction and Trading as the Lowest Calculated Bid in the amount of Php 4,972,993.32;

WHEREAS, after careful examination, validation and verification of all statements made and documents submitted by MAM Construction and Trading, as stated in the bidding documents, the Bids and Awards Committee found that the submission of MAM Construction and Trading passed all criteria for post-qualification;

NOW THEREFORE, the members of the Bids and Awards Committee, in regular session assembled:

RESOLVED, as it is hereby resolved, the following;

- To declare the bid of MAM Construction and Trading in the amount of Four Million Nine Hundred Seventy Two Thousand Nine Hundred Ninety Three Pesos and 32/100 (Php 4,972,993.32) as the Lowest Calculated and Responsive Bid in accordance with Section 34.4 of the Updated RIRR of RA 9184; and
- To recommend the award of the Contract to MAM Construction and Trading in the above-mentioned amount in accordance with Section 37.1 of the same RIRR;

RESOLVED FURTHER, to submit the foregoing recommendations to the Head of the Procuring Entity for approval.
