WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly [Supply and Delivery of 734 Drug Test Kit (METH/THC) 25's/kit and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of [(One Million Four Hundred Sixty Seven Thousand Two Hundred Sixty Six Pesos, Philippine Currency (PhP 1,467,266.00)] (hereinafter called "the Contract Price").
